**WHEREAS**, the City of Clairton desires to work with the Live Well Allegheny Campaign to accomplish its goals and shares many of them; and

**WHEREAS**, The City of Clairton actively promotes:

- A voluntary wellness campaign for all residents
- Adopted policies for smoke-free buildings and participates in the Tobacco Free Allegheny’s “Young Lungs at Play” program for community playgrounds
- Promote and support Farmer’s Market in the City
- Promote wellness activities at community events
- Promote and participate in the Annual 5K run /walk
- Participate in the promotion of the Montour Trails bike and walking trail that goes through the City
- Encourage the adoption of healthy food options at community events such as the Easter Egg Hunt, Halloween, Holiday Season Light-Up and Family Fun Nights
- Share information on wellness activities occurring in the broader community to encourage residents to participate
- Continue to work with Jefferson Hospital and its Wellness programming

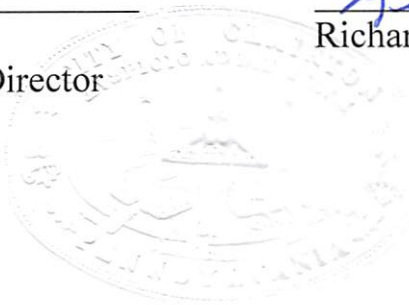
