## A RESOLUTION

**OF THE CITY OF McKEESPORT, ALLEGHENY COUNTY, PENNSYLVANIA, AGREEING TO WORK COOPERATIVELY WITH THE LIVE WELL ALLEGHENY CAMPAIGN THROUGH THE ESTABLISHMENT OF “LIVE WELL MCKEESPORT”, AND TO WORK TOWARD THE SHARED GOALS OF PROMOTING HEALTHY LIVING, WELLNESS AND QUALITY OF LIFE FOR ALL LOCAL RESIDENTS.**

**RESOLVED**, by the City of McKeesport, in Council assembled, that:

**WHEREAS**, Allegheny County, through the leadership of Allegheny County Executive Rich Fitzgerald, and Health Department Director Dr. Karen Hacker, launched “Live Well Allegheny” to promote healthy, active living; and

**WHEREAS**, the City of McKeesport desires to work with the “Live Well Allegheny” campaign to accomplish its goals, of which it shares many; and

**WHEREAS**, City of McKeesport actively promotes health and wellness through: (1) promotion of recreational programming that encourages physical activity with youth sports clinics and community events, (2) recognition of smoke-free children’s play areas at neighborhood playgrounds in partnership with Tobacco Free Allegheny, (3) further development of the William Lickert, Jr. Memorial Walking Trail in Renziehausen Park, and (4) utilization of the City website and social media to increase awareness of wellness opportunities sponsored by the City of McKeesport and community-based organizations; and

**WHEREAS**, the City seeks to share information on wellness campaign events with the broader community to encourage the voluntary participation of residents; and

**WHEREAS**, the City seeks a holistic approach to improving the quality of life for everyone in the City, including not only physical health, but financial empowerment and food security.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of McKeesport, Allegheny County, Pennsylvania, and it is hereby resolved by authority of the same as follows:


